Recommendation	Confidence Level	General Description				
BUY	Strong	Strong buy signal, often supported by positive fundamental news				
TB - Trading Buy	Somewhat Strong	Just break above key resistance level with strong trading volume				
SB - Speculative Buy	Somewhat Neutral	Traded / closed near strong (horizontal or diagonal) support levels				
H - Hold	Neutral	Tend to move sideways on a certain price range, has 50-50 chance to trade positive or negative depending its upcoming breakout pattern				
TP - Take Profit	Somewhat Neutral	Traded / closed near strong (horizontal or diagonal) resistance levels				
SOS - Sell on Strength	Somewhat Strong	Just break below key support level with strong trading volume				
SELL	Strong	Strong sell signal, often supported by negative fundamental news
