In session 1, JCI closed negative 0.32% to the level of 6,125.27

#### Market Prediction (Session 2)

JCI : The index closed down to level 6,125. JCI is still in a reasonable correction and there is still a chance to strengthen again. But be careful if JCI breakdown below support level.

- ASII : The price closed a slight correction and is still in our buying range. The price still has a chance to strengthen if it closed above support level. Confirmation to buy wait for bullish return and breakup to level 5,300. Be careful if the price closed below support level.
- INKP : The price crossed the first target at 7,675 (+3.02%), and closed at 7,875 (+5.7%). The price is likely to continue strengthening to the second target at 7,950 and 8,000. If the price is able to break up to level 8,000 and stay above it, the price has the chance to continue strengthening to 8,700. Be careful if it fails to break or the nearest price move back below level 7,500.
- MLPL : The price had strengthened to the level of 525 (+3.96%) and closed at the level of 510 with a bearish candle. The price still has a chance to strengthen if it closed above support level. Confirmation to buy wait for bullish return and breakup to level 515. Be careful if the price closed below support level.
- TLKM : The price closed in slight correction and is still in our buying range. The price still has a chance to strengthen if it closed above support level. Confirmation to buy wait for bullish return and breakup to level 3,420. Be careful if the price closed below support level.

# News

- PT Telkom Indonesia Tbk (TLKM) during the first six months of 2021 was able to boost performance with a record net profit attributable to owners of the parent entity was recorded at IDR 12.45 trillion, an increase of 13.30 percent from net profit of IDR 10.98 trillion the previous year.
- PT Pan Brothers Tbk (PBRX) recorded a net profit of USD 11.682 million in the first six months of 2021, or decreased by 3.2 percent compared to the same period in 2020 which amounted to USD 12,079 million.
