JCI closed down with a bullish candle. The stochastic indicator is again golden cross, MACD histogram is moving negative (line is weak) and volume is down. If JCI is bullish again, there is still a chance for JCI to strengthen again to the nearest resistance at the range of 6,123 - 6,150. If JCI moves bearish, JCI will move back to support at the range of 6,042 - 6,052.

(BJBR) The price closed higher with a bullish candle and a trendline support breakout. The price has a chance to strengthen again to the next resistance. The stochastic indicator is bullish, MACD histogram is moving positive (bullish line) and volume is increasing. Confirmation to buy if the next candle is bullish again or buy on weakness in the support area if it goes down first. We suggest to be careful if it fails to stay above the support level. (Trading buy)

## **TRADING STRATEGY:**

- 1.Target Price: The price has a bullish opportunity to test the resistance level 1,365. If it breaks level 1,365 then the price will go to level 1,385. We recommend to be careful if the price fails to break through or turn around the support area.
- 2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level of 1,295.

(BKSL) The price closed higher with a bullish candle and will test the nearest resistance. The price has a chance to strengthen again to the next resistance. The stochastic indicator is bullish, MACD histogram is moving positive (bullish line) and volume is increasing. Confirmation to buy if the next candle is bullish again or buy on weakness in the support area if it goes down first. We suggest to be careful if it fails to stay above the support level. (Trading buy or buy on weakness)

## **TRADING STRATEGY:**

- 1.Target Price: The price has a bullish opportunity to test the resistance level 73. If it breaks level 73 then the price will go to level 76. We recommend to be careful if the price fails to break through or turn around the support area.
- 2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level of 64.

Entry Buy : 67 - 69Target Price : 73 - 76Support : 65 - 67Cutloss : 64



### **EXCL**



(EXCL) The price closed higher with a bullish candle and breakout to the resistance. The price has a chance to strengthen again to the next resistance. The stochastic indicator is bullish, MACD histogram is moving in a positive direction (potential golden cross line) and volume is increasing slightly. Confirmation to buy if the next candle is bullish again or buy on break at level of 2,730. We suggest to be careful if it fails to stay above the support level. (Trading Buy)

#### TRADING STRATEGY:

- 1.Target Price: The price has a bullish opportunity to test the resistance level 2,770. If it breaks level 2,770 then the price will go to level 2,800. We recommend to be careful if the price fails to break through or turn around the support area.
- 2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level of 2,640.

#### **MNCN**



(MNCN) The price closed higher with a bullish candle and there is a chance to form an inverted head and shoulder pattern. The price has the opportunity to strengthen again to the next resistance if it manages to break out of the resistance. The stochastic golden cross indicator, MACD histogram is moving positive (bullish line) and volume is increasing. Confirmation to buy if the next candle is bullish again or buy on break at level of 890. We suggest to be careful if it fails to stay above the support level. (Trading buy or buy on break)

## TRADING STRATEGY:

- 1.Target Price: The price has a bullish opportunity to test the resistance level 905. If it breaks level 905 then the price will go to level 925. We recommend to be careful if the price fails to break through or turn around the support area.
- 2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level of 855.
